The land tenure for the project is Freehold therefore this wholly extinguishes Native Title.

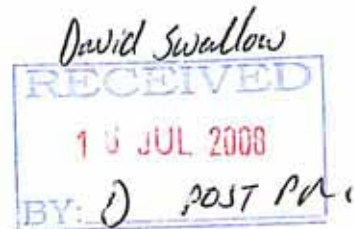
As Native Title is wholly extinguished there is no requirements to notify any Native Title parties.

SUBJECT: **Advice from Aboriginal Heritage Study - East Rockingham WWTP**

I refer to the above project and the documents provided to the IRS to examine the Aboriginal Heritage Issues within the project area.

For the Desktop Study, IRS conducted research into the previously recorded sites and reports in and around the Project Area (PA). The sites and reports research was based upon a search of the DIA Register of Aboriginal Sites via on-line access using the approximate PA coordinates. IRS then used GIS technology *ArcView* to plot the registered sites on a map to indicate their proximity to the PA.

The results of the study established that no Aboriginal Heritage sites were located within the Project Area.

**Recommendation:**

An Aboriginal Heritage survey was previously carried out on the proposed site location. As the alignment for the WWTP has now moved there are no Aboriginal Heritage Issues located with the Project Area.

All work can proceed as there are no Aboriginal Heritage Issues located within the project area.

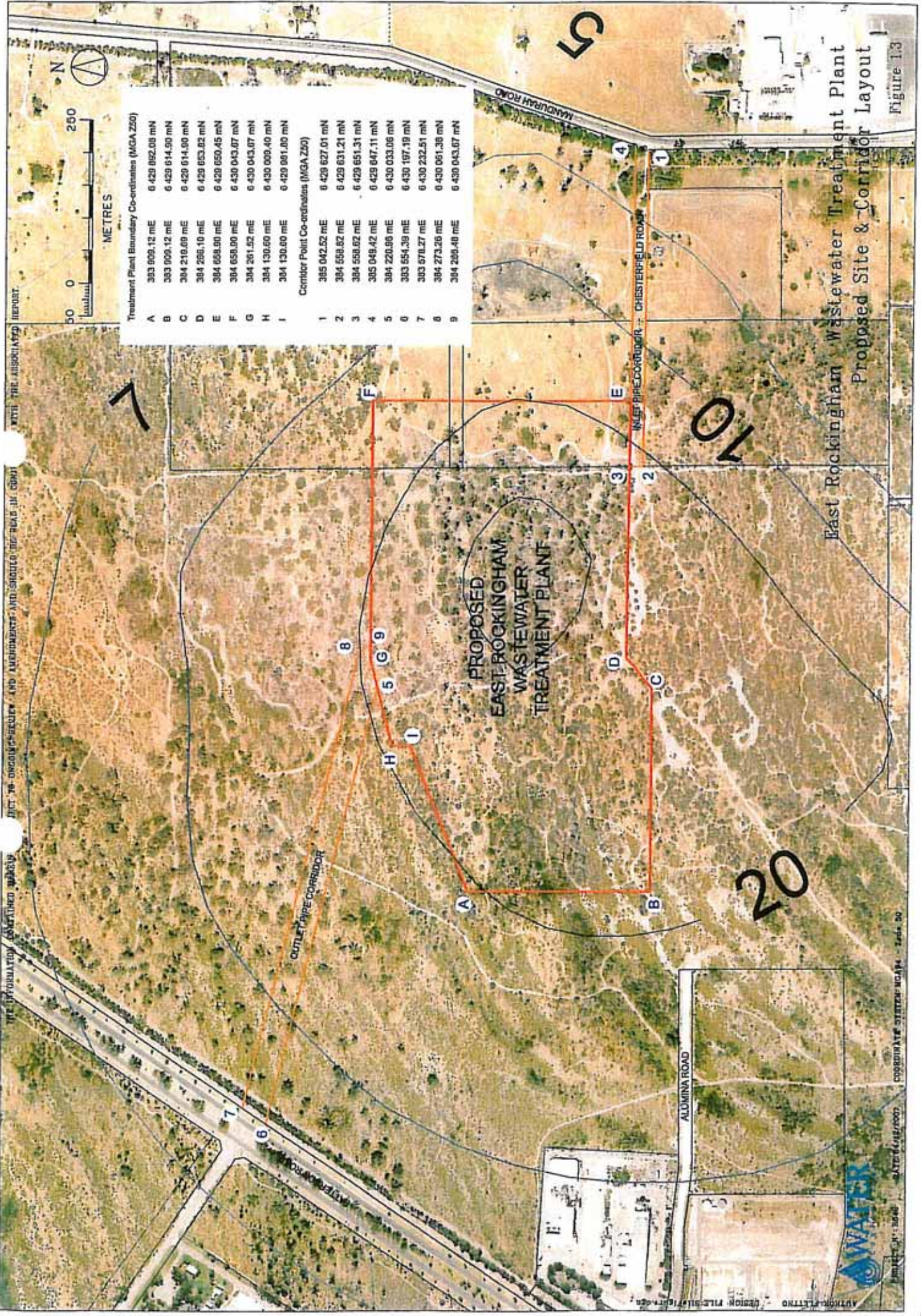
